- Designing plans for the development of the areas envisaged by the undersigning parties
- Implementing actions for the development of the human resources in the areas of origin of the undersigning parties
- Utilizing the infrastructure developed in the context of MarCh
- Maintaining and expanding the digital infrastructure (digital portals) developed within MarCh project
- Implementing counseling interventions to businesses in the areas envisaged
- Designing business plans and offering guidance to young entrepreneurs and already operating businesses
- Carrying out diagnostic analyses for businesses in order to help them to strengthen their competitiveness
- Enhancing the cooperation between the business and the research community
- Enhancing the cross border cooperation of enterprises and organizations between the two countries of origin of the here undersigning parties
- Cooperating with other Collective Bodies of Entrepreneurship and Professional Organizations
- Cooperating with Local and Regional Authorities and other public bodies and
- Carrying our any other activity contributing to the scope of the present.

Membership

Members of the MS BuSSes can become any legal entity which agrees with the scope of the present and accepts it in its totality after submission of an application and its approval by the Board.

A member can be excluded upon decision of the majority of the Board Members.

Governance





The Monitoring Structure is managed by a Management Board consisting of one representative of each of the herein undersigned parties.

The Management Board meets regularly once a year during the month of January of each calendar year and irregularly when it is considered necessary.

Decisions are made upon a single majority of the Board members participating in the board meeting.

A board meeting has a quorum when at least three of the herein undersigned parties are present.

The Board is chaired by its Chairman. The Chairman of the Board is each calendar year alternated. Chairman for the year 2024 is Mr. Alyosha Sinabov

Responsible for convening the Board Meetings is the Board Chairman.

Resources

The status of the MS is non-profit.

Members of the MS may be reimbursed for services provided to the MS upon decision of the Board.

The resources of the Structure may be:

- Funding from the participation in projects and activities financed by the EU or the governments or local governments of Greece and Bulgaria
- Fees reimbursed from the provision of services
- Donations
- Any other funds deriving from activities of the MS.

The seat of the MS is in
